Do I need an Electronic Travel Authorisation (ETA) to enter the UK?

How do I get to University Of London - Senate House?

From London Heathrow Airport:

- By car: 1 hour 15 minutes (19.5 miles) via A40
- By London Underground (public transport): board the Piccadilly Line towards Cockfosters and get off at Russell Square.

From London Gatwick Airport:

- By car: 1 hour 40 minutes (28.9 miles) via M23 and A23
- By train and London Underground (public transport): board on train towards Victoria Station. From Victoria Station you can take a taxi or public transport towards Russell Square Station.

From London Stansted Airport:

- By car: 1 hour 20 minutes (35.4 miles) via M11
- By train and London Underground (public transport): board on train towards Tottenham Hale. From Tottenham Hale, you can take public transport towards Russell Square Station.

- Russell Square
- Brunswick Square (5-minute walk)
- Tottenham Court Road (10-minute walk)

Transport

Bus:

• Numbers 1, 24, 29, 68, 73, 91 and 390 stop in the surrounding streets of Tottenham Court Road, Gower Street, or Russell Square.

Rail:

• Euston and Kings Cross, St Pancras are local mainline stations.

London Underground:

- Russell Square Piccadilly line (do not use the stairway except in an emergency, there are 175 steps)
- Tottenham Court Road Central line, Northern Line, Elizabeth Line
- Goodge Street Northern line
- Warren Street Victoria line
- Euston Square Circle, Hammersmith & City and Metropolitan Lines.

Where are the closest cash withdrawal machines located?

- Russell Square Station (5-minute walk)
- Holborn Station (10-minute walk)
